#### HILLSBORO CHURCH OF CHRIST WEDDING POLICIES

**Congratulations!** The Bible clearly says that marriage is honorable. It is God's idea - and a great idea! We wish to be of service in this important step in your life. Our desire is to bring couples closer to Christ and to each other throughout the process. Please call us at 937-393-1752 if you have any questions.

Wedding will not be scheduled on our calendar until the bride and/or groom (or one of their representatives) have:

Met with and HCC staff member to review the terms and conditions of the agreement. In addition, all fees for building use (Sanctuary and/or Connection Café and kitchen must be paid in full at this time to insure your date is guaranteed.

- A HCC staff minister, or minister of a sister Church of Christ/Christian Church shall officiate or assist in each wedding.
- Our decorations on stage and in the foyer change often. Please check the month prior to your scheduled wedding date to see if the decorations will fit in with your wedding, and if not, who should move them.
   Instruments must remain on the stage. If you feel they need to be moved, please contact our worship minister to arrange this (his information is on the next page).
- If amplified sound or recorded music is to be used, you must use one of Hillsboro Church of Christ's sound technicians. The bride and groom must contact the church to arrange for a technician through our worship minister (his information is on the next page).
- Our custodian (Jeanette Ludwick) serves as a helpful on-site coordinator during the rehearsal and wedding
  as well as opening, closing, and cleaning the building. She is available to you for the rehearsal and rehearsal dinner for a total of four hours and a total of six hours on your wedding day. Please plan accordingly.
  You must give her a call at 937-402-7470 as soon as your wedding is scheduled so she will put it on her calendar.
- Building use fees cover a portion of the wear, maintenance and the extra utilities incurred by using the building for your special event.
- The use of alcohol, smoking and illegal drugs are all prohibited on Hillsboro Church of Christ property. It is up to the bride and groom to enforce this.

PLEASE NOTE: ALL WEDDINGS MUST START BEFORE 5:00 PM <u>AND</u> THE SANCTUARY CLEARED BEFORE 7:00 PM

IF THE RECEPTION IS AT THE CHURCH, THE CONNECTION CAFÉ MUST BE CLEARED BY 9:00 PM

\$250.00	For the officiating minister (Payable to the minister)	Due at the rehearsal
